- The fund takes into consideration environmental, social, and governance factors in its investment process.

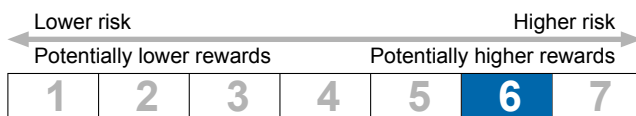
#### Other Information

- There are higher costs involved in buying and selling shares in India. These costs reduce the value of your investment but are not included in the Ongoing Charges figure below.

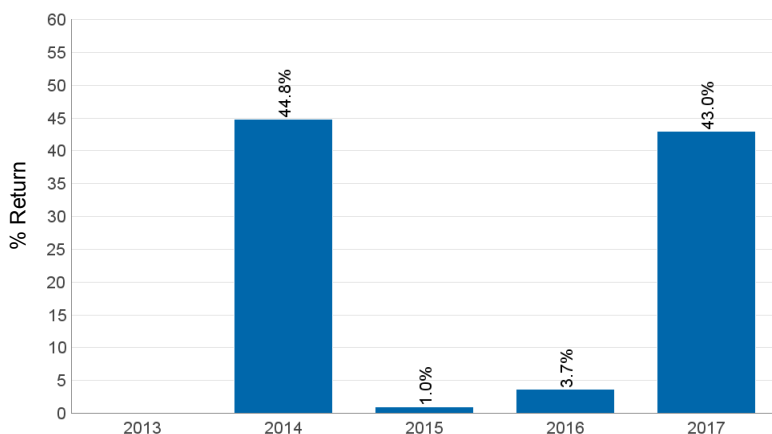
