- Companies based in Central, Eastern and Southern Europe (including Russia), the Middle East and Africa.
- The fund takes into consideration environmental, social, and governance factors in its investment process.

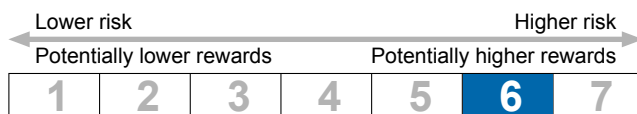
Other Information

- The fund may also invest part of its assets in companies based in the Central Asian states of the former Soviet Union.
- Income will be included in the value of your shares.
- The fund may also invest part of its assets in other investments, which seek to generate a similar return to company shares without direct ownership of the company.
- There are higher costs involved in buying and selling shares in this region. These costs reduce the value of your investment but are not included in the Ongoing Charges figure below.

Buying and selling shares

- Investors may buy and sell shares on any Luxembourg business day.

Due to the nature of the markets in which the fund invests, there might be circumstances where the safekeeping and custody arrangements of the fund are not as secure as those of more developed markets.

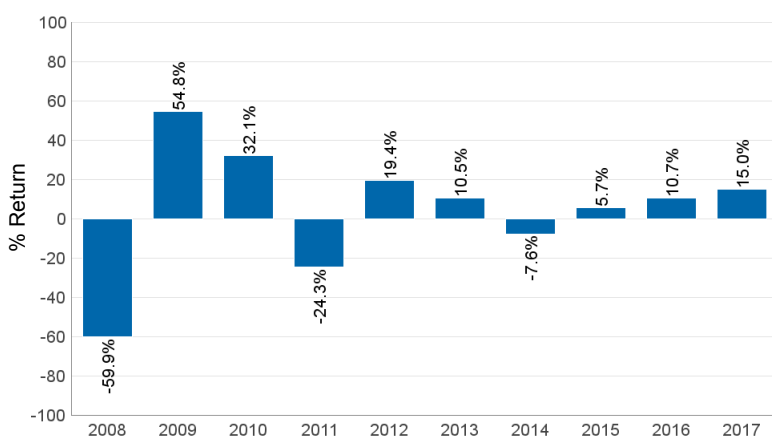
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
