OBJECTIVES AND INVESTMENT POLICY

Objective

- To generate income and the long term growth of your investment

Main Investments

- At least 70% of the fund's investments will be in fixed income securities (e.g. bonds).

Investment Policy

- High quality bonds issued in Euro. Bonds are high quality if they are rated BBB- or better by S&P or Baa3 or better by Moody's. The fund may continue to hold bonds which have had their rating lowered but may not buy more.
- Bonds with less than 5 years until the bond is fully repaid

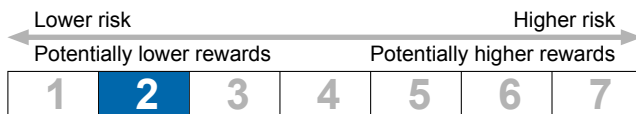
Other Information

- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfill contractual obligations and carry more risk. Refer to the prospectus ('Use of Derivatives' section) for more details.
- Income will be included in the value of your shares.

RISK AND REWARD PROFILE



The risk and reward category shown is based on historic data.

- The value of bonds are likely to decrease if interest rates rise and vice versa.

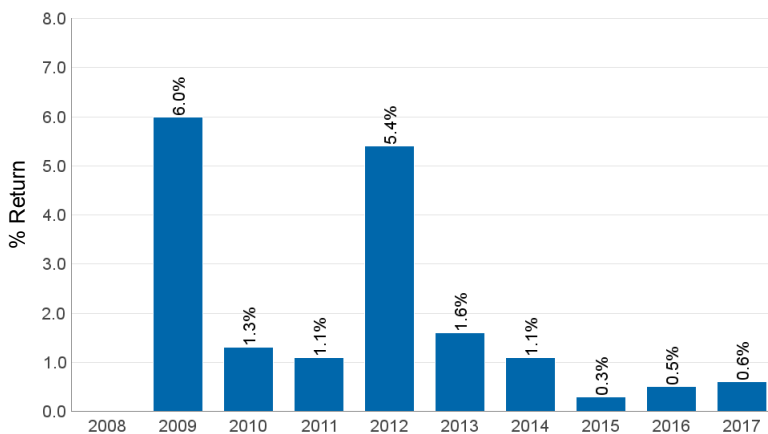
