OBJECTIVES AND INVESTMENT POLICY

Objective

- Long term growth of your investment

Main Investments

- At least 70% of the fund's investments will be in company shares.

Investment Policy

- Companies based in or carrying out most of their business in the Asia Pacific region excluding Japan, including funds such as Real Estate Investment Trusts. Where funds and trusts are used the investor may indirectly bear the ongoing management costs of those investments as well.
- The fund takes into consideration environmental, social, and governance factors in its investment process.

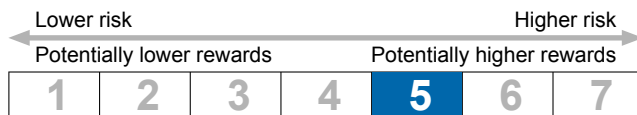
Other Information

- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.
- The fund may also invest part of its assets in other investments, which seek to generate a similar return to company shares without direct ownership of the company.
- There are higher costs involved in buying and selling shares in this region. These costs reduce the value of your investment but are not included in the Ongoing Charges figure below.

Buying and selling shares

- Investors may buy and sell shares on any Luxembourg business day.

- In order to achieve the currency hedging, this share class relies on other parties to fulfil certain contractual obligations, as these parties may fail to do so there is a higher risk to your investment.

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

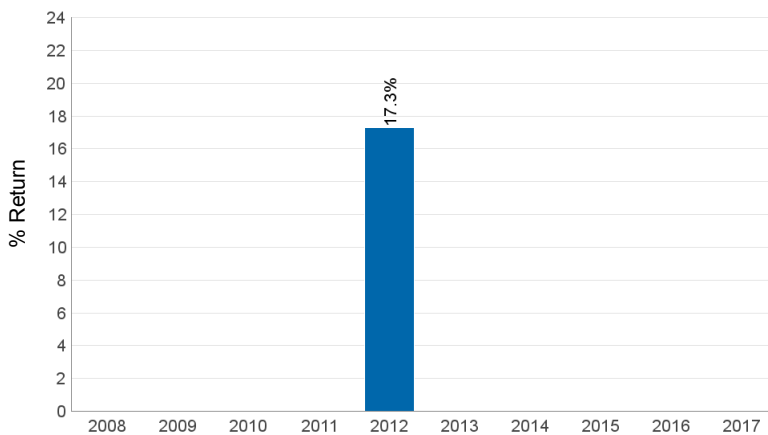
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
