OBJECTIVES AND INVESTMENT POLICY

Objective

- Long term growth of your investment

Main Investments

- At least 70% of the fund's investments will be in company shares.

Investment Policy

- The fund will primarily invest in companies based in or carrying out a significant portion of their business in frontier emerging markets. Frontier emerging markets are developing markets that have traditionally been difficult for foreign investors to enter or which are in an earlier stage of development than traditional emerging markets.
- The fund takes into consideration environmental, social, and governance factors in its investment process.

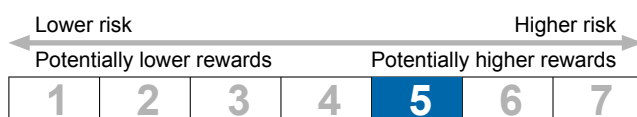
Other Information

- The fund may also invest part of its assets in other investments, which seek to generate a similar return to company shares without direct ownership of the company.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfill contractual obligations and carry more risk. Refer to the prospectus ('Use of Derivatives' section) for more details.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.
- There are higher costs involved in buying and selling shares in this region. These costs reduce the value of your investment but are not included in the Ongoing Charges figure below.

Buying and selling shares

- Investors may buy and sell shares on any Luxembourg business day.

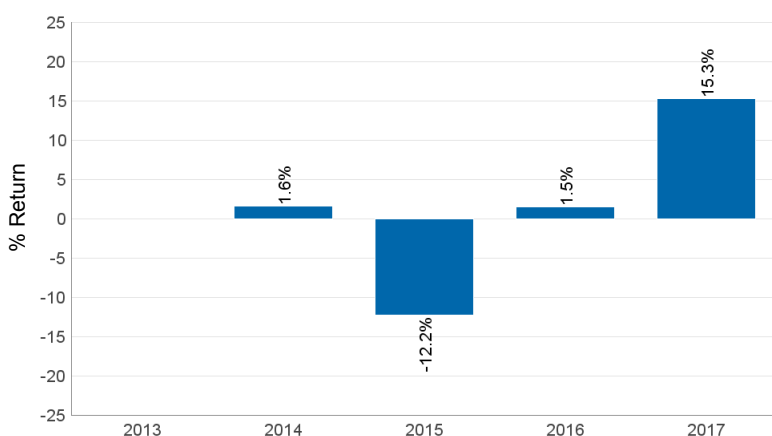
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
