#### OBJECTIVES AND INVESTMENT POLICY

##### Objective

- To generate income and the long term growth of your investment

##### Main Investments

- At least 70% of the fund's investments will be in fixed income securities (e.g. bonds).

##### Investment Policy

- Lower quality bonds issued in European currencies. These bonds usually offer a higher yield than high quality bonds. Lower quality bonds are defined as being rated lower than BBB- by S&P or Baa3 by Moody's.

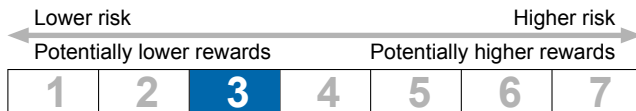
##### Other Information

- Other fixed income securities that do not meet the above criteria, for example bonds issued in non European currencies.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfill contractual obligations and carry more risk. Refer to the prospectus ('Use of Derivatives' section) for more details.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.

##### Buying and selling shares

- Investors may buy and sell shares on any Luxembourg business day.

#### RISK AND REWARD PROFILE



The risk and reward category shown is based on historic data.

- The fund may be impacted by movements in the exchange rates between the fund's currency and the currencies of the fund's investments.

This rating does not take into account other risk factors which should be considered before investing, these include:

- The value of bonds are likely to decrease if interest rates rise and vice versa.
- The value of financial derivative instruments are highly sensitive and may result in losses in excess of the amount invested by the Sub-Fund.
- Issuers may not be able to repay their debts, if this happens the value of your investment will decrease. This risk is higher where the fund invests in a bond with a lower credit rating.
- The fund relies on other parties to fulfill certain services, investments or transactions. If these parties become insolvent, it may expose the fund to financial loss.
- There may be an insufficient number of buyers or sellers which may affect the funds ability to buy or sell securities.

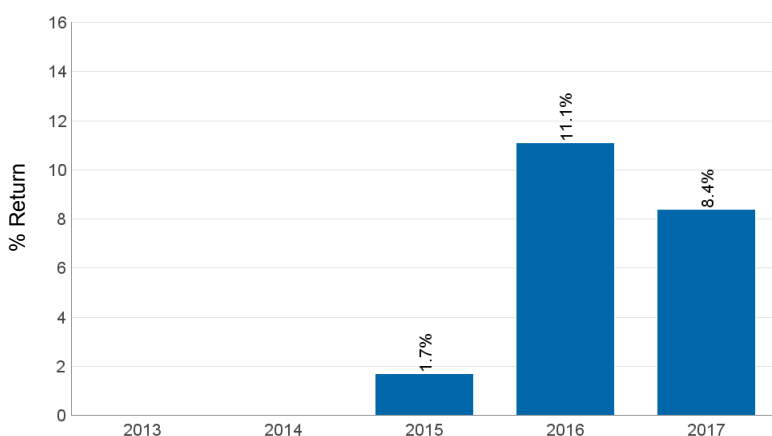
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
