### OBJECTIVES AND INVESTMENT POLICY

#### Objective

- The fund's objective is to generate a positive return

#### Main Investments

- At least 70% of the fund's investments will be in fixed income securities (e.g. bonds) and fixed income securities which convert into equity when they mature.

#### Investment Policy

- Fixed income securities issued in various currencies and locations, by governmental agencies and private businesses, rated B- or better by S&P or B3 or better by Moodys at the time of purchase.

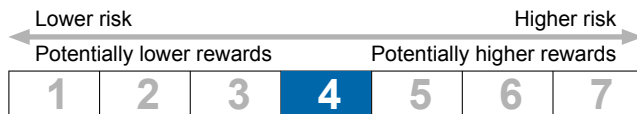
#### Other Information

- The fund may invest in cash, company shares and similar investments.

### RISK AND REWARD PROFILE

This rating does not take into account other risk factors which should be considered before investing, these include:

- The value of bonds are likely to decrease if interest rates rise and vice versa.

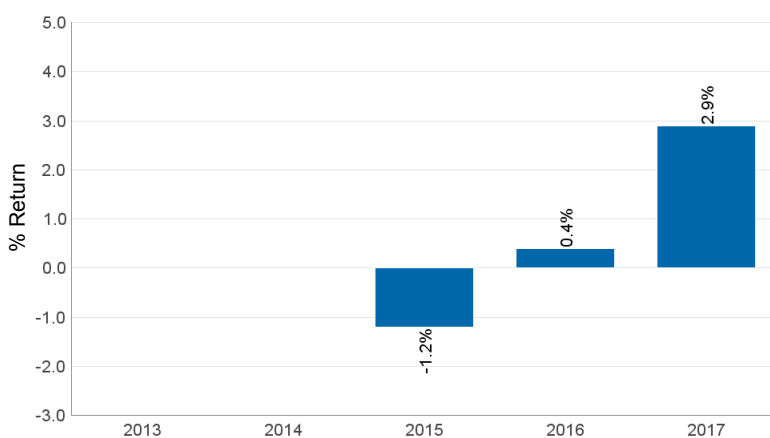
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
