### OBJECTIVES AND INVESTMENT POLICY

#### Objective

- The fund's objective is to provide an absolute return, while actively managing total portfolio risk.

#### Main Investments

- Company shares, exchange traded funds, fixed income securities, derivatives of shares and fixed income securities, currencies, structured products such as commodity linked notes

#### Investment Policy

- Based on fundamental economic research, the fund invests across asset classes, industries, countries and regions depending on where it sees the best potential for return. The fund actively manages risk and seeks to limit the potential for losses.

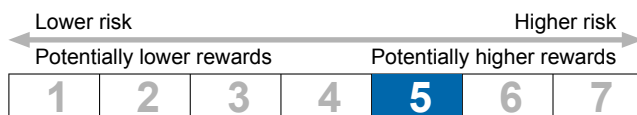
#### Other Information

- Structured products are contracts which take their value from various investments within them including derivatives.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfill contractual obligations and carry more risk. Refer to the prospectus ('Use of Derivatives' section) for more details.
- This is a currency hedged share class. It aims to reduce the impact on your investment of movements in the exchange rate between the fund currency and the share class currency.
- Income will be included in the value of your shares.

### RISK AND REWARD PROFILE



The risk and reward category shown is based on historic data.

This rating does not take into account other risk factors which should be considered before investing, these include:

- The value of bonds are likely to decrease if interest rates rise and vice versa.

- Issuers may not be able to repay their debts, if this happens the value of your investment will decrease. This risk is higher where the fund invests in a bond with a lower credit rating.

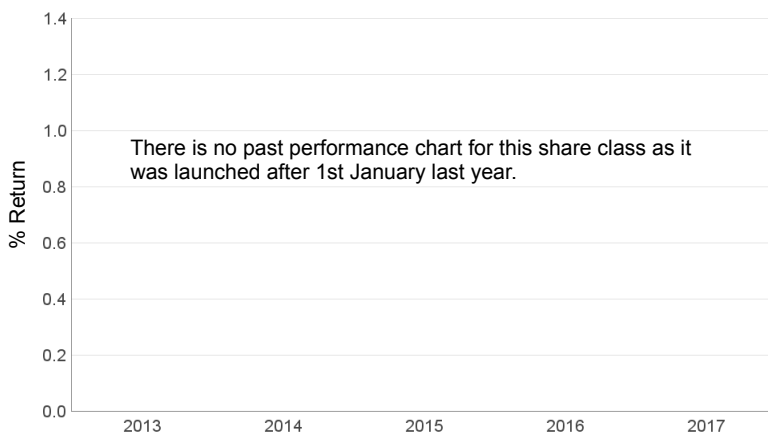
